Job Title: Packaging Maintenance Manager
Reports to: Plant Manager

POSITION SUMMARY

General responsibility for packaging, process and electrical maintenance function to include, but not limited to directing and coordinating equipment upkeep, development and implantation of preventative maintenance programs, and directing continuous improvement projects. This position will work closely with the Plant Manager and requires a high level of technical competency.

ESSENTIAL DUTIES AND RESPONSIBILITIES

- Develop, implement and maintain plant wide preventative maintenance program.
- Manage parts purchasing, inventory and vendor relationships.
- Maintenance reporting to include:
 - Planned maintenance – completed vs. scheduled
 - Unscheduled maintenance rates
 - Personnel utilization
 - Work order expenses
 - Equipment specific maintenance
- Identify capita needs focused on maintenance and continuous improvement.
- Direct maintenance capital projects to include complete scope of project research to completion, including management of onsite contractors.
- Budget expenses according to business plan.
- Secure project bids and job bids as needed.
- Supervise staff of salary and hourly employees to accomplish department objectives to include:
 - Appropriate staffing levels
 - Performance reviews
 - Personnel training and development
- Ensure compliance with regulatory agencies including OSHA and FDA. Responsible for department compliance with GMP and FSMA guidelines.

ADDITIONAL DUTIES AND RESPONSIBILITIES

- Demonstrate leadership and ability to get results
- Develop and improve manufacturing and process improvements
- Must be available for “on call” as needed
- Ability to travel
- Any and all other duties as assigned by the Plant Manger

QUALIFICATIONS

- Three to five years management experience, preferable in Packaging or Process Maintenance.
- College graduate in related field or completed apprenticeship
- Ability to react effectively to changing priorities
- Knowledge of 5S and Lean Manufacturing principles a plus
- Strong written and verbal communication skills
- Strong computer skills, including PM Software experience
- Ability to work effectively in a team-centered environment
